Ingredients: dark couverture chocolate (cocoa min. 52.1%) (74%) (cocoa mass, sugar, cocoa butter, **milk** fat, emulsifier: **soy** lecithin, natural vanilla flavouring), soft **wheat** flour, coloured nonpareils (7%) (sugar, **wheat** and corn starch, glucose syrup, food colours: apple concentrate, blackcurrant, lemon, radish, safflower, spirulina, concentrated beetroot juice, rapeseed oil, oil coconut, glazing agents: white beeswax, carnauba wax), sugar, refined coconut oil, corn starch, emulsifier: **soy** lecithin; **egg** yolk powder, dextrose, skimmed **milk** powder, **soy** flour, salt, flavourings
